Consensus is that while this has some merit the rule is that a chronometer check is required every basketing night with the Federation Clock Foreman, It would require a notice of motion at the next AGM to amend the rule.

J.O. also asked if T. Lanzenby could be refunded his fees for season 2020 the fees paid in 2020 transferred to 2021 season. T Lazenby to only raced one race in season 2020 before his birds became sick.

If for some reason you can't pick the bird up reasonably quicky call the local club lost bird officer and hopefully he will help. We must attend promptly to public reports of stray birds and please thank them for taking care of your bird. We do not need/ want any negative feedback.

**Truck Update K.W.** advises that a major service is due. M. Jupp explained that he has a neighbour who has done work on his trucks over the years. It was suggested that for the major service we use the regular business [OHR] as they have the truck history and then use M. Jupp's mechanic for the smaller maintenance jobs.

Also the water pump for the drinkers needs replacing. The batteries are not holding charge. There is either a fault in the batteries or new ones required. A battery bank is also needed for the fans so as we don't have a repeat of when the truck broke down last season.
