Australian Taxation Office

Overdue Notice ATO – April, May, June Business Activity Statement [BAS]

While we have kept our financial records in order and up to date, we have fallen behind with submission of our BAS to the ATO. It is critical that we bring this matter into order and submit our BAS to the ATO, now. The ATO gave the PRF a deadline to remedy the matter and submit our BAS statement for the April, May, June quarter by 24 September 2024. BAS on behalf of the PRF. Jatin Cholera of Nexia Corp Accounting & Tax 8/15 Bonner Drive, Malaga, WA 6090 [Tax Agent number 82294004] quoted the PRF \$350 a quarter which amounts to \$1400 per taxation year. We were paying John Wintle \$2,200 per year plus Superannuation in the amount of \$250. In addition to his honorarium the PRF were paying \$513.00 per year to access the accounting programme 'Cash Flow'. The whole accounting exercise is costing the PRF \$3,000.00 per year, plus cost of stationary, which has been considerable.

Minutes of the, August and September meetings of the ANRPB are available on the PRF website. No July meeting.

Gascoyne North Fed 100 Race

All pigeons placed in the top 5 in the last race of the season, Gascoyne North Fed 100, have had their particulars checked by 2 authorized members of the PRF within 48 hours of the results becoming known and the pigeons tossed. All 5 pigeons particulars are correct and all 5 pigeons homed to their respective designated lofts.

Kevin Wilson Appeal – Disqualification of Gascoyne Nth Fed 100 Pigeon

Kevin Wilson addressed the Board as to his grounds for appeal and reasons as to why his appeal should be upheld based on the fact that two PRF members, namely Barry Yon and Tony Sluymers, were present when K Wilson's pigeon homed from the Fed 100, Gascoyne North, they

checked particulars of the pigeon and witnessed the pigeon being recorded on "Training Mode" of his Benzing ETS clock.

Considerable discussion took place as to why K Wilson's appeal should fail based on the wording of Rule 23 of the EBSS rules, namely;

23. If race entry data is deleted (whether accidentally or deliberately) from the EBSS clock (either prior to basketing, **prior to the race**, after the race, **or at any time** prior to the basketing sheet **or** race result sheet being printed), the competitor shall be disqualified from the race of that week.

Board members were then invited to move a motion.

Moved: K Damon that due to the fact that Kevin Wilson produced witnesses, including PRF Clock Foreman Garry Wilson, to verify particulars of the pigeon and its time of arrival, K Wilson's appeal be upheld.

Stray Pigeons

Members are reminded of their obligation under the Race Rules to report stray pigeons to the Lost Bird Officer as soon as possible. Any member found disposing of a stray pigeon fitted with a PRF life ring, a Fancy Bird Association or Country Member's life ring, will have their membership reviewed by the Board of Control.

The SKA [Square Kilometre Array] Project in Australia was discussed in general terms relative to the impact on our pigeon's ability to home. The Australian project is located 350 kms north east of Geraldton and 250 kms from the coast. For more information Google, "The SKA Project in Australia."

ANRPB - Champion Pigeon Awards

The Australian National Racing Pigeon Board (ANRPB) is pleased to announce that as from this year (2024) they are looking to award an Australian pigeon that achieves the best performance in an individual Federation and or Combine of Clubs that has a minimum membership 20 competing fanciers with the title of "National Ace Pigeon".

In the "Short to Middle National Distance Ace Bird Award" (80km to 500km) category the nominated bird must be clocked three times within the nominated distance, this can be twice from the same race point/distance, but third clocking must be from a different race point/distance with the 80 to 500km distance.

In the "Middle to Long Distance National Ace Bird Award" (501 to 900+km) the nominated pigeon must be clocked twice from a race point/distance from any two races within this distance 501 to 900+km.

Additional/New Award

To be awarded the "National Overall Ace Bird Award" (80km to 900 + km) the nominated pigeon must be clocked at least three times, either once in the "Short to Middle Distance Category" (80km to 500km) and twice in the "Middle to Long Distance Category" (501 to 900+km) or vis-versa i.e. twice in the "Short to Middle Distance Category" and once in the "Middle to Long Distance Category"

All nominations need to be on the Official ANRPB Nomination Forms that can be downloaded from the ANRPB website, or from your own Federation or Club website and signed by the relevant officials as highlighted on the forms. All Nominations need to be received by the 31/1/25.
