**Notice of Motion:** Matt Creemers Race Rule 63.1 Amend time for all clubs to Clock Out to read 42 hours after liberation, as opposed to 72 hours after the race closes.

**Notice of Motion:** Matt Creemers. Amend Rule 8.1 to read life rings to be issued to on first day of July of each year.

**Notice of Motion:** Matt Creemers Amend Race Rule 21.1 Pigeon must home to member's loft. Amend number of hours to verify pigeon's particulars etc., from 48 hours to 72 hours.

**Notice of Motion:** Fred Scerri, Amend APPENDIX A Rules and Conditions of Installation and use of Electronic Band Scanning Systems – November 2014 by deleting clause 6 in its entirety and replacing it with a new clause 6, as follows.

"Manual clocks requiring rubber rings are to be phased out over a twelvemonth period [Period commencing May Y25 racing season]" The amendment includes certain exclusions, namely for new flyers and flyers of a certain age.

# Notice of Motion: EBSS Rule 23

(a) In the event of the above Rule 23 occurring, if the owner of the EBSS clock can produce and print a complete set of race data e.g.) Race Entry Form (Basketed list of Birds) Race birds clocking arrival evaluation sheet with the date and time of arrival, birds colour pattern, sex and life band prefix year and number regardless of whether in training or any other mode and a race run variation time be produced against the Federation Chronometer (Loss & Gain) and a result can therefore be determined, then the competitor's position shall stand.
